NAMCABS -Train the Trainers Workshop for Members of Faculty of training establishments of banks (Online mode)

The Reserve Bank of India launched the National Mission for Capacity Building of Bankers for financing the MSME sector (NAMCABS) in 2015. The capacity building of bankers under NAMCABS includes training the trainers of training establishments of commercial banks who conduct programmes with same/similar content for the officials of their bank dealing with MSME financing.

2. For the academic year 2021-2022, the CAB has scheduled to conduct Training of Trainers Programme on NAMCABS for the Members of Faculty of Training Establishments of Scheduled Commercial Banks.
