**Online Programme on Financing Collectives (FPO, JLG and SHG)
(August 10-14, 2020)**

The College of Agricultural Banking (CAB), RBI, Pune is conducting a five-day online **Programme on Financing Collectives (FPO, JLG and SHG) during August 10-14, 2020** for officers of Commercial Banks and RRBs. The objectives of the programme are:
